AN ORDINANCE OF THE CITY OF GREENLEAF, CANYON COUNTY, STATE OF IDAHO, ADJUSTING GREENLEAF CODE SECTION 9-15-4(B) TO CLARILY USE OF ROBERT'S RULES OF ORDER IN THE CONDUCT OF HEARINGS UNDER THE PROCEDURES, APPEALS AND ACTION CHAPTER (CHAPTER 15) OF THE LAND USE DEVLOPMENT ORDINANCE (TITLE 9); PROVIDING FOR REPEAL OF CONFLICTING PROVISIONS; PROVIDING FOR SEVERABILITY; DIRECTING THE CITY CLERK FOR ORDINANCE NUMBER, CODIFICATION, AN EFFECTIVE DATE, AND PUBLICATION.

WHEREAS, the City of Greenleaf is a municipal corporation organized and operating under the laws of the State of Idaho; and

WHEREAS, At the District 3 Spring 2025 Association of Idaho Cities (AIC) meeting it was noted by the Honorable Mayor of Emmett that if a specific version of Robert's Rules of Order is required by City Code for conduct of proceedings and variance from that specific version of Robert's Rules occurs, then there may be risk of procedural challenge of city processes; and

WHEREAS, the City of Emmett's code section 2-5-5 uses the language '...following the precepts of the "Robert's Rules of Order"; and

WHEREAS, the City Council for the City of Greenleaf deems it in the best interest of the community to amend Greenleaf Code as follows,

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Greenleaf, Canyon County, Idaho as follows:

Section 1: That Greenleaf Code §9-15-4(B) be amended as follows:

§9-15-4(B) The chair of the meeting shall conduct the hearing following the precepts of "Robert's Rules of Orderin accordance with the "Robert's Rules Of Order", newly revised, or its most recent revision.

Section 2<u>:</u> Repealer. All previous ordinances, resolutions, orders, or parts thereof, in conflict herewith are hereby repealed, rescinded and annulled.

Section 3: Severability. If any section, subsection, clause or phrase of this Ordinance is held by a court of competent jurisdiction to be invalid, such decision shall not affect the remaining portions of this Ordinance.

Section 4: Ordinance Number; Codification. The City Clerk is hereby directed to assign the next ordinance number in sequence and schedule this Ordinance for publication and codification.

Section 5: Effective Date; Publication. This Ordinance, or a summary thereof in compliance with Idaho Code §50-901A, shall be published once in the official newspaper of the City, and shall take effect following its passage, approval and publication
