- 5 <u>Consideration of 21795 Main Street Re-zone Application</u> [ACTION ITEM] (Clerk's Note: At the 23 January 2024 City Council Meeting, consideration of the application was tabled and remanded to city staff to work with the applicant and bring back to Council.)

Discussion began regarding Idaho Transportation Department (ITD) access, and whether or not the city can proceed without ITD access being finalized by the applicant. Determination by the City Attorney was that the city does not appear to be precluded from addressing the application, if a condition for ITD approval is included. Discussion continued. It was noted that Canyon County does not proceed with applications until access is finalized, and that this is common. Discussion continued regarding which should come first, the city rezone or the ITD access. Desire was expressed to require the access first, due to potential precedence with future applications and having applicants incur expense with conditions that the city does not have any control over, such as ITD access. It was noted that access does not exist until it exists, conditioned or not.

It was suggested that the city provide a letter stating that the city is working with the applicant for forward to ITD. Discussion followed.

Staff was directed to require ITD access as a condition precedent to applications wherever applicable.

Dan Hyer moved to table with direction to staff for development of a letter asking ITD for verification that the applicant has access to the highway, should the Council grant a request for rezone from neighborhood commercial to community commercial. Rachel Brobeck seconded. The motion received unanimous approval.
